The Northwestern District Attorney's Office has been home to a local consumer protection program since 1973. The Consumer Protection Unit's Director, Anita Wilson, and Case Coordinator Joanne O'Donoghue are trained specialists who work to resolve consumer complaints through an informal process and also provide resources and referrals to the public.
